VERY IMPORTANT INFORMATION:

Parents,

I have gathered ALL the cost for the tournament fees and such for the Spring season, as I know them right now. The total cost is \$4,339.53 for the team. Divided by 17 players, this works out to \$255.27 per player.

This includes the following ...

- WSA Community Shield February 12, 2010
- Wichita Papa John Midwest Invitational March 26 – 28, 2010
- WSA CUP April 16 – 18, 2010
- Mazzio's Presidents Cup April 24 – 25, 2010
 - There could be additional costs of coach expenses (hotel cost and per diem) if we make it into the finals in Edmond on May 8 – 9, 2010.
- KC Legends Patriot Cup May 28- 31, 2010
- Home game referee fee's Spring Season
- Team game ball Per Kevin King

I realize this is A LOT to come up with all at once, so I have broken it down into three payments based upon how I have to pay for the tournaments and referee fees. But PLEASE UNDERSTAND that if you choose to pay it out ... I MUST HAVE IT by the dates shown! If I do not have it by then I cannot proceed with registration and payment for next tournament and the entire team suffers.

First payment February 12, 2010
\$102.00 per player

Second payment March 15, 2010
\$80.62 per player

Third payment **May 1, 2010**
\$72.65 **per player**

Lastly, if you want to pay the tournament fee's and spring training fee's in one lump sum (January – May) that total amount is \$505.27
